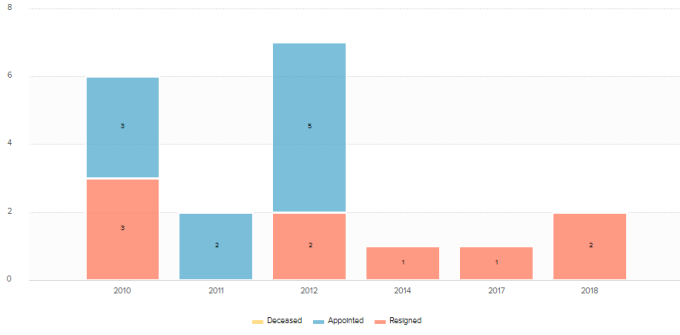

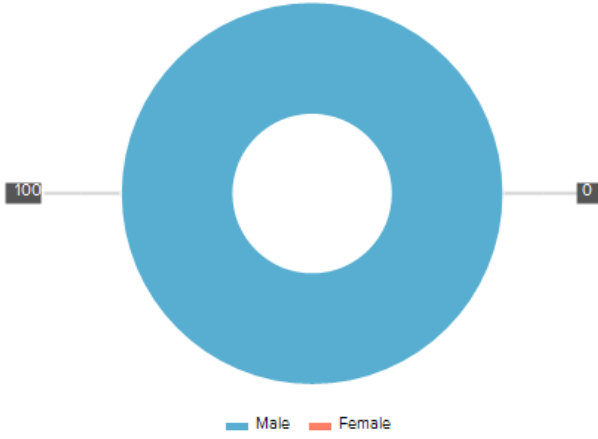
## DIRECTOR TIMELINE
